-Council member McKelvey thanked his supporters and would like to see the first reading of the alcohol at public event ordinance to be at the next meeting.

-Council member Henderson wished everyone a happy Thanksgiving.

-Council member Williams asked about a guard rail at Ivy and Emory streets. Also

wants to consider the raised crosswalks mentioned earlier in the meeting.

- Council member Keck asked for clarification on Ms. Suber's transitional housing request.

-Council member Morgan thanked our Veteran's and asked the Council to look at ordinances that would require builders of new neighborhoods to install speed humps.

-Mayor Johnston asked the community to embrace each other and not show hate. He also said the Ethylene Oxide and Matt Cooper situations are excellent examples of what the community is capable of accomplishing.
