Introduction

This is the Sixth Code Enforcement Report of the 2020 calendar year. The June report starts with a categorization of code enforcement cases by violation type and summarizes them for the City as a whole. A bar chart provides a breakdown of cases by category.

Report Highlights

- Removal of Illegal signage from the right -of -ways was the most frequent violation during this reporting period.
- The Marshal staff removed approximately **86 signs** placed in the City's Public Right of Ways.
- In the current reporting period, the Marshal's office surveyed over 1,065 properties.
- We did 44 New Inspections and created 24 new cases.
- We also have located 44 vacant/boarded-up houses.

Total Cases


