2. Motion made by Council member Morgan, seconded by Council member Williams to approve the **final** reading of an ordinance for the City of Covington with changes: to allow townhome standards within the Covington Town Center Overlay that are different than townhome standards generally applicable city wide found at 16.28.025, as recommended by planning commission but with requirement that townhome component comply with existing guidelines for sidewalks and require the use of architectural shingles:

"AN ORDINANCE OF THE CITY OF COVINGTON, GEORGIA, TO AMEND THE COVINGTON MUNICIPAL CODE, ENACTED AND ADOPTED ON THE 16<sup>TH</sup> DAY OF OCTOBER, 2001, AS AMENDED BY PREVIOUS AMENDMENTS, TO ALTER CERTAIN PROVISIONS OF TITLE 16 OF THE SAID CODE OF ORDINANCES FOR THE PURPOSE OF **AMENDING SECTION 16.24.040 (COVINGTON TOWN CENTER OVERLAY ZONING DISTRICT) OF CHAPTER 16.24 (OVERLAY ZONING DISTRICTS),** TO REPEAL CONFLICTING ORDINANCES AND FOR OTHER PURPOSES."
