REGULAR MEETING, MAYOR AND COUNCIL, CITY OF COVINGTON, GEORGIA, COUNCIL ROOM, SEPTEMBER 6, 2022, 6:30 PM.

Mayor Steve Horton presided with Mayor Pro-tem Fleeta Baggett, Council members: Susie Keck, Kenneth Morgan, and Don T. Floyd, City Manager Tres Thomas, Assistant City Manager John King, Deputy Clerk Amanda Huggins, and City Attorney Frank Turner, Jr. present. Council member Anthony Henderson, Council member Charika Davis, and City Clerk Audra M. Gutierrez were absent.

Pastor Brad Rutledge and Renee Rutledge of HOPE Church gave the invocation.

Mayor Horton led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Council member Floyd gave an update on the health status of former Council member Roger Tingler. Council member Floyd informed Mr. Tingler tripped on a rug at his home resulting in a small brain bleed. Council member Floyd stated that besides being sore, Mr. Tingler is doing ok, and asked everyone to keep the Tingler family in their prayers.

Mayor Horton administered the Oath of Office to new Covington Police officers Crystal Cintron and Scott Strickland.

Mayor Horton explained an open records request to the Covington Police Department would need to be made in order to get copies of body camera footage.

Ms. Thelma Nolley stated she asked the owner of the property beside her if he would not mind cleaning up area around of the fence boarding her property. Ms. Nolley stated that the City has torn up her fence by taking down trees that her neighbor requested to remove. Ms. Nolley stated gas lines were not marked before the tree removal. Ms. Nolley questioned if the City Manager's son was qualified to work for the City and how a human resource employee has three family members recently employed by the City. Ms. Nolley is concerned that City employees are not qualified for certain positions. Ms. Nolley stated concern of charges for furniture not picked up by trash service in the past and requested sending a notice to inform citizens 2 pieces of furniture can be picked up per cycle currently.

Comments from the City Manager:

-Tres Thomas stated he understands there are times when employees approach Council members about various concerns/grievances, but he would like the Council member to give the supervisors and managers of the employee an opportunity to address them before engaging. Mr. Thomas referenced City Policy 506.

Council member Keck questioned where the City stood on getting a trailhead on Dearing Street at the backside of Covington Place as the bank is becoming a mess from people walking up it and it is dangerous. Council member Keck stated she witnessed a Wal-Mart 18 wheeler truck coming down Elm Street through

downtown from Porterdale.

Council member Baggett mentioned the lenders who have given money for the dog park behind Chimney Park have been paying for trash pickup and maintenance as the park is owned by the County. Council member Baggett stated former City Manager Scott Andrews and Loyd Kerr were working on the dog park before they left.

Community Development Director Ken Malcom stated Randy Connor has been in touch with some of the family of the lenders and is working on getting some answers on the dog park.

City Attorney Frank Turner Jr. stated Newton County owns Chimney Park and the dog park and have an agreement with Friends of Newton Parks to maintain it. City Attorney Frank Turner Jr. mentioned an agreement drafted with the Elder family that was never signed.

Ms. Thelma Nolley questioned who determines where sidewalks are in neighborhoods.

City Attorney Frank Turner Jr. stated he will check the ordinance and clarify sidewalk placement.
