## REGULAR MEETING, MAYOR AND COUNCIL, CITY OF COVINGTON, GEORGIA, COUNCIL ROOM, SEPTEMBER 19, 2022, 6:30 PM.

Mayor Steve Horton presided with Mayor Pro-tem Fleeta Baggett, Council members: Anthony Henderson, Kenneth Morgan, and Don T. Floyd, Assistant City Manager John King, City Clerk Audra M. Gutierrez, Deputy Clerk Amanda Huggins, and City Attorney Frank Turner, Jr. present. Interim City Manager Tres Thomas was absent. Council members Susie Keck and Charika Davis joined meeting via teleconference.

Mayor Horton gave the invocation and led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Horton presented a proclamation honoring Newton County Emergency Director Jody B. Nolan for his service to the community and acknowledging August 21, 2022 as "Jody Nolan Day" in Covington, Georgia.

1. Motion made by Council member Morgan, seconded by Council member Floyd to approve the minutes from the Regular Council Meeting held on September 6, 2022.

Motion carried unanimously.

A detailed discussion ensued regarding build-to-rent single-family detached developments.

2. Motion made by Council member Baggett, seconded by Council member Morgan to approve **final** reading of an ordinance for the City of Covington, with changes to language to include requiring on-site property management and maintenance:

Mr. Jeff Bulloch, developer in charge of Neely townhomes, spoke in favor of request from Neely Farms Residential L.L.C. to grant a 12-month extension for City of Covington to approve final plat and obtain Land Disturbance Permit for townhomes and traffic light.

6. Motion made by Council member Morgan, seconded by Council member Henderson to approve request by Neely Farms Residential L.L.C for a 12-month extension for City of Covington to approve final plat and obtain Land Disturbance Permit for townhomes.

Motion carried unanimously.

Mr. Carl Westmoreland of 3343 Peachtree Road NE Atlanta, GA spoke in favor of a request for a 12-month extension of SUP for 10200 and 10020 City Pond Road. Mr. Westmoreland stated a letter from City Manager Tres Thomas explained issues of traffic and water sewer capacity were resolved.

7. Motion made by Council member Morgan, seconded by Council member Baggett to approve request for a 12-month extension of SUP for 10200 and 10020 City Pond Road.

Motion carried unanimously.

A public hearing was held at 7:19 PM concerning future land use and zoning of 39.91 acres located at 70 McGuirts Bridge Road from NR-1 to NR-2 proposed single-family residential development. Planning and Zoning Director Marc Beechuk gave detailed report from staff. Mr. Charles Moore of 1776 Peachtree Street NW Atlanta, GA spoke in favor of single-family future land use and zoning designation from NR-1 to NR-2 of said property, presenting a detailed proposal of future development. Mr. Chris Martin of 650 Mason Drive spoke against, stating the proposed development does not fit in with already established neighborhoods, increased traffic is concerning, and investment in the community from renters is not typical. Mr. Greg Maloney of 1380 Fairfield Road spoke against, voicing increased traffic and density concerns along with possibilities of poor future property management. Mr. Tony Harris of 1000 Todd Drive spoke against, stating proposed development would greatly disrupt already established neighborhoods. Mr. Charles Moore explained GDOT and City engineers address traffic concerns. Council member Baggett stated part of McGuirts Bridge is on National Registry and GDOT cannot do any work on it, as well as voiced concerns of high density. Council member Henderson questioned if proposed development is allowed under City ordinance. Council member Floyd voiced concerns of traffic volume from new Eastside High School as well as ingress and egress for emergency vehicles. Council member Davis questioned how many for rent homes are permitted under current zoning and where the subdivisions were in City with homes not selling. City Attorney Frank Turner, Jr. stated 10% of houses in development have to be rentals to qualify as build to rent. Council member Henderson and Council member Baggett stated all renters

are not bad people and can be productive, viable members of community. Council member Baggett stated she is not a supporter of compact rentals, and location is bad for this project.

8. Motion made by Council member Morgan, seconded by Council member Davis to approve future land use and zoning of 39.91 acres located at 70 McGuirts Bridge Road from NR-1 to NR-2 Proposed Single-Family Residential Development.

Motion withdrawn by Council member Morgan.

9. Motion made by Council member Morgan, seconded by Council member Davis to approve future land use as a single-family residential development of 39.91 acres located at 70 McGuirts Bridge Road.

Motion carried unanimously.

10. Motion made by Council member Morgan to approve rezoning of 39.91 acres located at 70 McGuirts Bridge Road from NR-1 to NR-2.

Motion dies for a lack of second.

11. Motion made by Council member Baggett, seconded by Council member Floyd to **deny** rezoning of 39.91 acres located at 70 McGuirts Bridge Road from NR-1 to NR-2.

Motion carried with Council members Keck, Floyd, Baggett, Henderson, and Davis voting for. Council member Morgan voting against.

A public hearing was held at 8:12 PM concerning a **first** reading of an ordinance concerning traffic calming measures.

Planning and Zoning Director Marc Beechuk gave a detailed report from staff. Mayor Horton mentioned the design of speed bumps at FFA Camp as an option as well. Council member Keck stated we have failed the community by not providing safety via speed control and mentioned the several types of speed control measures in the City of Bostwick. Council member Morgan clarified with City Attorney Frank Turner, Jr. the text amendment pertained to newly built communities only. Council member Floyd stated speed bumps slow response times of emergency vehicles.

12. Motion made by Council member Morgan, seconded by Council member Baggett to approve a **first** reading of an ordinance for the City of Covington:

A public hearing was held at 8:30 PM concerning a text amendment to the Clark's Grove Overlay Zoning District.

Planning and Zoning Director Marc Beechuk gave a detailed report from staff. Mr. David Hamilton of 100 Peachtree Street Ste. 1450 Atlanta, GA 30303, Mr. Douglas Tuller of 2141 Emory Street, and Mr. Scotty Scoggins of 5122 Swann Street spoke in favor of Clark's Grove Overlay. Mr. Hamilton stated none of the single-family complex buildings are over three stories, with 145 apartments and 84 townhomes. Mayor Horton questioned developers if repairing and re-opening Old Browns Bridge Road was an option, and developer stated traffic studies showed repair would not help traffic, but they would be willing to consider repair work cost.

Planning and Zoning Director Marc Beechuk gave a detailed report from staff. Mr. Jay Mitchell of 4545 Wieuca Road Atlanta, GA 30342 spoke in favor of proposed future land use and zoning designation. Council member Floyd questioned if intent was to build a spec building. Mr. Mitchell informed the intent was to build a spec building. City Attorney Frank Turner, Jr. informed future land use map is appropriate and a map amendment is not required.

14. Motion made by Council member Morgan, seconded by Council member Floyd to approve zoning of 17.8111 acres of a 66.47 acre parcel located at 10665 Hwy 278 from NR-1 and CM (Corridor Mixed-Use) to M-2 (Heavy Industrial) with conditions recommended by staff.

Mayor Horton requested Council members to think about a plan for Baker's Field and Conyers Street gym, and stated discussion will continue at a work session arranged by Assistant City Manager John King.
