## REGULAR MEETING, MAYOR AND COUNCIL, CITY OF COVINGTON, GEORGIA, COUNCIL ROOM, JANUARY 3, 2023, 6:30 PM.

Mayor Steve Horton presided with Mayor Pro-tem Anthony Henderson, Council members: Susie Keck, Fleeta Baggett, Charika Davis, Kenneth Morgan, and Don T. Floyd, City Manager Tres Thomas, Deputy City Manager John King, City Clerk Audra M. Gutierrez, Deputy Clerk Amanda Huggins, and City Attorney Frank Turner, Jr. present.

Mayor Horton gave invocation and led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Horton presented a proclamation honoring Mrs. Martha Logan Banks.

Mayor Horton administered the oath of office to new CPD Officer Rashad Rivers.

Gas Director Mike Jewell gave an update on the gas line bids for the Hwy 11/Hwy 278 Roundabout project. Mr. Jewell stated Harrison & Harrison withdrew their bid and D. Lance Souther Inc. was the only other bidder. Mr. Jewell stated Harrison & Harrison paid a 5% penalty bond to the City amounting to \$11,847.50 for withdrawing their bid therefore, D. Lance Souther Inc. was awarded the project in the amount of \$306,550.00 minus the penalty for a total project cost of \$294,702.50.

Ms. Thelma Nolley stated she did not receive a response from anyone regarding her complaint against a speeding trash service driver. Ms. Nolley stated she placed a call with Customer Service at the end of November per protocol, and is concerned the driver will cause harm to someone.

Mr. Lee Durden of 4158 Floyd Street stated green space is very nice for the community, and questioned why green space lots are divided in order to create more density. Mr. Durden stated this happened at the corner of Dearing and Floyd Streets, and he is against it. Mr. Durden would like the City to see the bigger picture of where we are heading with this process. Mr. Durden stated investors/developers of new apartments do not care about anything but returns, and crime is increasing as a result.

City Clerk Audra M. Gutierrez left meeting at 7:11 PM and returned at 7:14 PM.

Mr. Bill Ross of ROSS + Associates presented a detailed PowerPoint presentation "Impact Fees 101" and explained a kick-off public hearing is required in accordance with Section (3) (a) of Chapter 110-12-2-.04 of the State's Development Impact Fee Compliance Requirement, as there is no current Impact Fees Program in the City of Covington.

A public hearing was held at 7:24 PM regarding said Impact Fee Program.

Mrs. Blaney Bostian of 4182 Floyd Street, NE questioned if current residents would see an increase in utility fees/property taxes, why not all cities have impact fees, and if green space is included. Mr. Ross stated impact fees only apply to new developments, municipalities suspended impact fees for a time but have begun re-initiating, and green space is included in parks and recreation but was accidently left out of his presentation. Mr. Brion Frix of 130 Cornish Trace Drive stated he is in support for an impact fee schedule, as it allows the City to get hold of growth and shift cost from current taxpayers. Mr. Frix stated all public services in the City are strained. Mr. Lee Durden restated concern for lack of green space. Council member Keck clarified with Mr. Ross impact fees would affect new projects only.

A public hearing was held at 7:42 PM regarding a SUP at 2119 Emory Street in the Town Center Mixed-use Zone allowing Recreational Goods Rental Use for the purpose of operating an online golf cart rental operation. Planning and Zoning Director Marc Beechuk gave a detailed staff report. City Attorney Frank Turner Jr. stated Emory Street is a state highway and golf carts may not travel on it,

although carts may cross at and travel on Usher St. Council member Keck stated the carts do not need to be on the grass and the accessory building needs work. Mrs. Blaney Bostian requested clarification on how said golf cart business operates and what the current use of property was. Mr. Beechuk stated currently there is online rental for the golf carts and the carts get delivered to renters, and three businesses share parking spaces. Mr. Brion Frix, Mr. Lee Durden, and Mr. Charlie Tuller of 715 Flat Rock Road with office at 2141 Emory Street spoke in support of the SUP with a condition allowing 6-8 golf carts maximum to allow parking for surrounding businesses. Mr. Lee Durden spoke against the SUP stating there is no agreement to share parking with applicant Mr. Jesse Gentes and surrounding businesses will have no parking. CPD Chief Stacy Cotton questioned the expectation of law enforcement in patrolling the state highway, and traffic accidents could likely increase at the Emory and Clark Streets intersection.
