## REGULAR MEETING, MAYOR AND COUNCIL, CITY OF COVINGTON, GEORGIA, COUNCIL ROOM, APRIL 3, 2023, 6:30 PM.

Mayor Steve Horton presided with Mayor Pro-tem Anthony Henderson, Council members: Susie Keck, Charika Davis, Kenneth Morgan, and Don T. Floyd, City Manager Tres Thomas, Deputy City Manager John King, City Clerk Audra M. Gutierrez, Deputy Clerk Amanda Huggins, and City Attorney Frank Turner, Jr. present. Council member Fleeta Baggett was absent.

Mayor Horton gave invocation and led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Horton read a proclamation acknowledging April as Child Abuse Prevention Month. Mayor Horton presented the proclamation to Lauren Gregory of A Child's Voice Child Advocacy Center, Inc., in attendance to discuss Child Abuse Prevention month. Ms. Gregory mentioned Pinwheel Palooza scheduled for April 11, 2023 at 10:30 AM-11:30 AM at 216 Brookstone Place Social Circle, GA 30025.

Mr. Scoggins also wanted to thank the businesses/merchants of the Covington Square.

Ms. Angi Beszborn of 1116 Clark Street stated her attendance was in regards to a complaint against her business, Mystic Grill, roping/blocking off two parking spaces one day a week (typically Saturdays) for 4-6 hours to display Vampire Diaries cars. Ms. Beszborn wanted to apologize, as she did not realized she was doing anything wrong, as several other merchants on the Square also block off parking spaces. Ms. Beszborn stated she has been blocking off parking for three and a half years with no complaints, and Vampire Diaries fans love the cars. Ms. Beszborn collected 601 names in two and a half days petitioning to continue to allow the display of the cars, and she is in favor of proposed permitting if necessary.

Mr. Mike Crowe of 25 Cornish Trace Drive stated opposition of the proposed apartments/multi-family development by Flat Rock Road (Alcovy Rd Overlay proposal). Mr. Crowe stated concern regarding the effects of the proposed development on the water reservoir, traffic, and roads.

City Planner Renee Criswell stated the owner of said property concerning the proposed re-zoning has requested tabling the discussion with the Planning and Zoning Commission until May 9, 2023. Ms. Criswell stated proper signage of proposed re-zoning shall be placed, public notices advertised, and information placed online and in City Hall lobby to keep citizens notified with updates.

Mayor Horton stated that after the Planning and Zoning Commission votes on proposal, the Council holds a public hearing and two readings as well. Mayor Horton reminded public wishing to speak during "Public Comments" to fill out a card prior to the meeting beginning.

Mr. Bradley Hill of Main Street Trolley stated the Vampire Diaries cars Ms. Angi Beszborn parks by the Mystic Grill are an attraction every business around the Square benefits from, at her own expense. Mr. Hill stated the cars are iconic along with other Vampire Diaries memorabilia, filming locations, and tourist attractions. Mr. Hill stated there should be exceptions for the fans, as they bring large revenue to the community.
