Mayor Steve Horton presided with Mayor Pro-tem Anthony Henderson, Council members: Susie Keck, Fleeta Baggett, Charika Davis, Kenneth Morgan, and Don T. Floyd, City Manager Tres Thomas, Deputy City Manager John King, City Clerk Audra M. Gutierrez, Deputy Clerk Amanda Huggins, and City Attorney Frank Turner, Jr. present.

Mayor Horton gave invocation and led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Horton administered the oath of office to new CPD Officers Denis Cerovic and Imani Roberson.

4. Motion made by Council member Floyd, seconded by Council member Keck to approve levying the 2023 Millage Rate at 5.764 mils.

Mr. Mitchell stated the motion to deny PMAJ23-0002 Griffin and PMAJ23-0005 Oakmont should state to approve appeal and deny Certificate of Appropriateness.

11. Motion made by Council member Floyd, seconded by Council member Keck to approve reconsideration of the motion to deny PMAJ23-0002 Griffin.

Motion carried unanimously.

Motion made by Council member Keck, seconded by Council member Baggett to accept appeal of the Historic Preservation Committee Certificate of Appropriateness approval for PMAJ23-0002 Griffin, and **deny** Certificate of Appropriateness for PMAJ23-0002 Griffin on map parcels C011A/003, 006, 016, 034, 040, 045, 047, 049 and 052.

Motion carried with Council members Keck, Morgan, Baggett, Davis, and Floyd voting for. Council member Henderson voting against.

13. Motion made by Council member Davis, seconded by Council member Keck to approve reconsideration of the motion to deny PMAJ23-0005 Oakmont.

Motion carried unanimously.

14. Motion made by Council member Keck, seconded by Council member Morgan to accept appeal of the Historic Preservation Committee Certificate of Appropriateness approval for PMAJ23-0005 Oakmont, and **deny** Certificate of Appropriateness for PMAJ23-0005 Oakmont on map parcels C011A/009, 011, 019, 024, 029, 031, 033, 039 and 043.

Motion carried unanimously.

Ms. Thelma Nolley stated the upkeep of the Square is to appease visitors only and the rest of the City is nasty. Ms. Nolley stated visitors do not pay taxes or vote, and the rest of the City needs upkeep. Ms. Nolley stated the trash man continues to be bad to Ms. Ruby Henderson who is elderly. Ms. Nolley discussed unfair hiring processes and pay scales of City employees, and told the City Manager the City needs order in place.

Mr. Charles Doppelheuer stated he is a representative to a new homebuilder in the area that has land on Carr Circle. Mr. Doppelheuer stated the goal is to build

affordable housing in character with surrounding builds. Mr. Doppelheuer stated according to City ordinances, there are currently no homes in surrounding area that pass, and suggested a variance.

Mayor Horton stated he had spoken with Mr. Doppelheuer and explained to him a text amendment initiation is needed, and Mr. Doppelheuer stated the reason he came before Council is to suggest the text amendment process be considered.

Mrs. Carla Ferry stated the Baker Field/Conyers Street Gym nomination submission for the Places in Peril program is complete and in November 2023 the program will announce ten Places in Peril which will allow promotion and fund raising to restore the field and gym. Mrs. Ferry stated she is creating a website called savebakerfield.com that will be up soon.

Mayor Horton stated City Council is working on a plan to get grants as well to support the Baker Field/Conyers Street Gym project.

Comments from the City Manager:

- Staff was unsuccessful at obtaining the CDBG associated with housing projects and all twenty-three applicants were notified
- In order to obtain funding for Baker Field/Conyers Street Gym, a proposed purpose for use of the rehabilitation project needs establishing
- Deputy City Manager John King stated the Fire Department won the Battle on Baker Field softball game against the Police Department

Mayor Horton asked Council to consider who can serve on the Newton County Tomorrow Board as a member, as Council member Davis has conflict with the meeting schedule. Mayor Horton stated a BBQ competition between the Fire and Police Departments is scheduled for August 26, 2023 from 9:00 AM-1:00 PM at Ace Mayfield Hardware, and the Newton County Chamber of Commerce State of Community event is scheduled for September 13, 2023 at the First Baptist Church of Covington Fellowship Hall from 11:30 AM-1:15 PM.
