## REGULAR MEETING, MAYOR AND COUNCIL, CITY OF COVINGTON, GEORGIA, COUNCIL ROOM, FEBRUARY 5, 2024, 6:30 PM.

Mayor Fleeta Baggett presided with Mayor Pro-tem Susie Keck, Council members: Anthony Henderson, Charika Davis, Kimberly Johnson, Travis Moore, and Jared Rutberg, City Manager Tres Thomas, Deputy City Manager John King, City Clerk Audra M. Gutierrez, Deputy Clerk Amanda Huggins, and City Attorney Frank Turner, Jr. present.

Rosie Crawford gave the invocation.

Mayor Baggett led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Baggett stated in recognition of Black History Month in Covington there are historical facts placed along the Cricket Frog Trail, artwork by local youth displayed at Legion Field, a history exhibit at the Welcome Center, and a parade scheduled on February 24, 2024.

Mayor Baggett read a proclamation designating the observance of Arbor Day the Third Friday in February 2024.

Randy Vinson of 450 Jenkins Road stated he would like to see a couple or minor adjustments to the Turner Lake Road Improvements project. Mr. Vinson stated if the median was shortened by two feet and the landscape strip on the west side between the sidewalk and the curb was shortened to five feet, the plans would be perfect.

Council member Rutberg stated the proposed plan includes gutter.

Mr. Vinson then stated an eight-foot multi-use trail versus a ten-foot trail should be considered, in order to assist with the 35 mph traffic flow.

Jeff Bishop of 10144 Twin Oaks Drive SW stated congratulations to the new Mayor and Council, and that he will support them. Mr. Bishop stated he would like Council to reconsider the decision on Downtown consumption and allowing open container. Mr. Bishop further stated he feels taxpayers should have been able to vote on the matter, and the public was not heard. Mr. Bishop stated he is concerned with underage consumers taking advantage of the decision as well as the increase of unruly behavior.

• Applauses to the Public Works department, particularly the Street department, for handling the Old Atlanta Hwy emergency situation involving a six inch water main

Council member Keck stated she would like to thank the City for repairing the damage to the Cricket Frog Trail due to a washout from the storms. Council member Keck further stated she will not be in attendance for the February 19, 2024 Council meeting.

Council member Rutberg stated he would like to thank Code Enforcement officers Danny Bartello and Freda Holloway for allowing him and Council member Moore to ride along and tour the City. Council member Rutberg requested Code Enforcement have permission to send out a public notice before making rounds in the City. Council member Rutberg further stated he researched the traffic on the Covington Bypass in front of the STEM Academy and 300 students that live in the City attend. Council member Rutberg stated he would like a letter sent to the Georgia Department of Transportation (GDOT) petitioning for a traffic light at the STEM Academy due to traffic accidents and congested traffic.

Mayor Baggett stated Gas Director Mike Jewell just returned from a visit to Washington D.C. to talk about natural gas, and the City has great department heads. Mayor Baggett reiterated the events taking place for Black History Month and Arbor Day.

City Manager Tres Thomas stated District 10 Representative Mike Collins reached out to him after Mr. Jewell's visit to Washington D.C. and is planning a site visit for February 12, 2024 in regards to a trucking company.
