Mayor Fleeta Baggett presided with Mayor Pro-tem Susie Keck, Council members: Anthony Henderson, Charika Davis, Kimberly Johnson, Travis Moore, and Jared Rutberg, City Manager Tres Thomas, Deputy City Manager John King, City Clerk Audra M. Gutierrez, and City Attorney Frank Turner, Jr. present.

Dr. Royeese Stowe gave the invocation.

Mayor Baggett gave invocation and led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Baggett acknowledged Boy Scout Troop 222 was in attendance with regards to the Eagle Scout's Citizenship in the Community Badge.

Mayor Baggett administered the Oath of Office to new Covington Police Officers Jasmine McNare, Ashley Futral, and James Sokol.

1. Motion made by Council member Rutberg, seconded by Council member Henderson to approve the minutes from the Regular Council Meeting held on August 5, 2024, with correction.

Motion carried unanimously.

2. Motion made by Council member Henderson, seconded by Council member Davis approve the **final** reading of an ordinance for the City of Covington, with the correction of "twenty-five thousand."

Mayor Baggett stated Deputy City Manager will be back at work tomorrow after his second foot surgery.

Council member Henderson stated for the next fireworks agreement he wanted to pitch having fireworks on Juneteenth starting in 2025.

Council member Rutberg thanked all who worked on the July 4th discussion, those who supported the Miracle League fund raising event, and those who worked on the Warming Shelter discussion.

Council member Moore stated at the last DDA meeting, it was discussed the gold stars needed to be repainted on the tiles around the square and the possibility of pressure washing & awning rehab.

Council member Johnson stated she rode out to Nelson Heights and admired the new sidewalks the Transportation Department is working on.

Council member Keck thanked those who was instrumental in getting the square pressure washed. Council member Keck mentioned her husband totaled his electric and the first thing the Fire Department did was cut the cables to the lithium battery. Council member Keck asked the City to look into getting 4-way stop signs on Industrial Boulevard at Wheat Street and Hazelbrand Road and Wheat Street. Council member Keck further stated to set up emergency contacts in your iPhone because it calls emergency services in case of a wreck and thanks again to public safety.
