REGULAR MEETING, MAYOR AND COUNCIL, COUNCIL CHAMBERS, CITY OF COVINGTON, GEORGIA, SEPTEMBER 2, 2025, 6:30 PM.

Mayor Fleeta Baggett presided with Mayor Pro-tem Kimberly Johnson, Council Members: Anthony Henderson, Travis Moore, Charika Davis, Jared Rutberg, and Susie Keck, City Manager Tres Thomas, Deputy City Manager John King, Acting Deputy Clerk Tiffany Johnston, and City Attorney Frank Turner, Jr. City Clerk Audra M. Gutierrez was absent.

Reverend Dr. Royeese Stowe gave the invocation.

Mayor Baggett led everyone in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Baggett administered the Oath of Office to new Covington Police Officers Austin Swint and Randy Downs.

1. Motion made by Council Member Davis, seconded by Council Member Henderson to approve the minutes from the Regular Council Meeting held on August 18, 2025 with changes to the public comments to reflect both Mr. Duane Ford and Mr. Robert Clay "attended."

Motion carried unanimously.

5. Motion made by Council Member Keck, seconded by Council Member Moore to approve the first reading of an ordinance for the City of Covington:

"AN ORDINANCE OF THE CITY OF COVINGTON, GEORGIA, TO AMEND THE COVINGTON MUNICIPAL CODE, ENACTED AND ADOPTED ON THE 16TH DAY OF OCTOBER, 2001, AS AMENDED BY PREVIOUS AMENDMENTS, TO ALTER CERTAIN PROVISION OF TITLE 5 OF THE SAID CODE OF ORDINANCES FOR THE PURPOSE OF AMENDING SECTION 5.04.040 (OCCUPATION TAX LEVIED) AND SECTION 5.04.080 (PAYMENT OF OCCUPATION TAX – EFFECT OF DELINQUENCY) OF CHAPTER 5.04 (BUSINESS LICENSES AND OCCUPATION TAXES GENERALLY) THEREOF, TO REPEAL CONFLICTING ORDINANCES AND FOR OTHER PURPOSES."

Motion carried with Council Members Keck, Johnson, Moore, and Rutberg voting in favor. Council members Davis and Henderson voting against.

6. Motion made by Council Member Keck, seconded by Council Member Henderson to approve the initiation of a text amendment to revise the ordinance to allow a Taphouse with the addition of "must have substantial snacks available."

Motion carried with Council Members Keck, Johnson, Davis and Henderson voting in favor. Council members Moore and Rutberg voting against.

7. Motion made by Council Member Keck, seconded by Council Member Moore to approve an Intergovernmental Agreement for the Collection of City of Covington Property Taxes by the Newton County Tax Commissioner.

Motion carried with Keck, Johnson, Moore, Rutberg, and Henderson voting in favor. Council member Davis voting against.
