# REGULAR MEETING, MAYOR AND COUNCIL, COUNCIL CHAMBERS, CITY OF COVINGTON, GEORGIA, NOVEMBER 17, 2025, 6:30 PM.

Mayor Fleeta Baggett presided with Mayor Pro-tem Kimberly Johnson, Council Members: Anthony Henderson, Jared Rutberg, Charika Davis, and Travis Moore, City Manager Tres Thomas, Deputy City Manager John King, City Clerk Audra M. Gutierrez, and Attorney Frank Turner, Jr. Council member Susie Keck was absent.

Reverend Dr. Royeese Stowe gave the invocation.

Mayor Baggett led everyone in the Pledge of Allegiance to the Flag of the United States of America. She also recognized incoming council member Dwayne Turner was in audience and congratulated him on his election.

Ms. Thelma Nolley requested city officials look into stormwater to prevent flooding in the Stone Mountain Street area after heavy rains.

City Manager, Tres Thomas, commended everyone working on the Downtown Masterplan. He also encouraged everyone to come to the lighting of the square on Thursday, November 20, 2025, 6:30-7:30PM.

Deputy City Manager, John King, invited everyone to come to Downtown Square Lighting on Thursday.

City Clerk, Audra Gutierrez, requested confirmation of who would be riding the float for the Covington Christmas Parade on Saturday, December 6, 2025. Council Member Henderson, Council Member Davis & Council Member Johnson confirmed they would be in attendance. Mayor Fleeta Baggett will be out of town. Council Member Rutberg will be out of town. Council Member Moore will be assisting with the parade in other areas.

Council Member Johnson congratulated Council Member Davis and Council Member Henderson for being re-reelected to their Council seats.

Council Member Moore stated that 11Alive News crews will be on site, for the lighting of the square on Thursday, for future story about Christmas in Covington.

Council Member Davis congratulated Apostle Rosie Crawford for her appointment at Wallace Grove Baptist Church. She thanked local non-profits for feeding the homeless each month. She thanked everyone that voted for her or encouraged and/or assisted with her campaign.

Council Member Rutberg congratulated everyone on being elected/re-reelected to council seats. He mentioned there was a record turnout of West Ward voters. He commended everyone working on the Downtown Masterplan.

Council Member Henderson asked if city officials were aware of flooding Ms. Nolley mentioned on Stone Mountain Street and when will it be addressed. City Manager, Tres Thomas, replied that he will look into it.

Mayor Fleeta Baggett commended Officer Blackwell for work on an accident scene. She encouraged everyone to come to the tree lighting on Thursday, where Officer Henry will be welcoming Santa and asked that everyone continue to pray for Officer Henry. She mentioned that 11Alive News would like people to wear coats so it appears cold. She informed everyone that Newton Ministers Alliance will be distributing Thanksgiving boxes at Legion Field and Trailblazer Park Saturday 11/22 beginning at 10:00AM. She encouraged everyone to assist in packing the boxes 11/21. She commended the Street Department for right-of-way cleanup. She reminded everyone that stormwater fees are not used for a specific area but to the entire city in the most beneficial manner.
